PRESIDENT'S MESSAGE from Steve Day

"Fish Don't Talk Back"

Now, I'm not only asking questions of myself out loud, but I'm answering myself out loud as well. The best I can come up with is to dream about Spring and the ample fishing opportunities that comes with it. Southern Oregon Coast

Food for thought from Otis Swisher

To ODFW study committee: re: simplification of fishing regulations

I attended the 16 June Info meeting in White City and had two comments 1) was re: opening of the Rogue River to trout fishing year round, as it was before Hooten (an ODFW Biologist) pushed through a change closing the entire River to trouting April 1 to Memorial Day week end).

My assumption was that the closure was to protect the hatchery smolts which take only 2 weeks to get to the ocean. In discussion, at that meeting I was told that the closure was to protect the Wild smolts on their downstream movement.

If this is the main purpose for the closure, let me suggest that your regulations must now reflect equally the need to protect the Adult Wild Spawners of the Wild Steelhead population during that same time. The present regulations allow the take of FIVE WILD STEELHEAD OF 24-INCHES AND LARGER during that same period of time.

These extra large fish have the best genetic structure of the winter run and, therefore, are the ones which maintain a healthy population for that Winter fishery. So, what you are trying to gain in the protection of spring smolts is being undone or thwarted by the taking of your best genes from your best adults. This is like the 8th grade math problem where you are to fill a tank while at the same time allowing an outflow to take place.

In a discussion with one of your fisheries biologists headquartered in your White City Office, I understand that the 5 Wild Fish exception rationale came by a Fishing Organization Group, saying that the breakdown of Steelhead in the Rogue System in April and May was a mix of clearly distinguishable Steelhead (Summer Steelhead were UP TO 24 inches in length, while Winter Steelhead were 24 inches and longer). Hence to protect the Summer fish run which was declining, fishers could take from the Winter fish population which in the club's judgment was a "healthy run" consisting of those distinguishable at 24 inches or longer. Wild fish UNDER 24 inches MUST be released.

I suggest that in the big picture, the Summer Run fish, which are primarily small and intermittent stream spawners, are now being aided by the removal of tributary dams, culverts, and other migration impediments such as those on Evans Creek thus permitting these small and intermittent tributaries of the Rogue to be more fully utilized for spawning, they are being assisted in your attempt to return them to a "healthy status".

Furthermore, with the removal of the main stream dams (Savage Rapids and Gold Ray) you now have a brand new river unimpeded from the ocean to plan for. Since the Winter Steelhead are known as main stream spawners, and the problems of riparian destruction and the effect of warming water protection, along with the lessening supply of recruitment gravels for spawning, I believe it is time for a new approach in the regulations which moves away from "we can steadily pick away at our healthy Wild Winter Steelhead population until it becomes threatened", to one which is based on the premise: The Public has demanded a Hatchery fish fishery, and we have given them their wishes since the opening of Cole Rivers Hatchery to the tune of 50,000,000 hatchery smolts; SO. let us NOW have a 50 year program with the emphasis on the place and need for Winter Steelhead which are the permanent foundation of the fish runs for even more years than we are planning for.

If it is necessary to provide a TAKE for the Barbeque Crowd, it should be from the 2,000,000 Hatchery smolts in the Spring, instead of from your best of the best of the Brood Stock, which are the BIG 24inches and larger spawner adults from the Wild fish brood stock which we are allowing to be killed because we are playing Russian Roulette with their numbers by saying "this is a healthy run, now". A better solution: NO WILD FISH TO BE TAKEN FROM THE STREAMS OF OREGON (EXCEPT BROOK TROUT, BULL TROUT... or others you designate.) This protects your wild smolts AND your best wild brood stock.

The future of all salmonid runs depends on the wild stocks which must be maintained, starting right now.
