Four dams on the Klamath River were removed last summer, and thousands of fish have already returned to the upper basin.

Trout Unlimited, alongside a coalition of commercial and recreational fisherman, federal and state agency partners, community leaders, and unwavering leadership from the Yurok, Karuk and Klamath Tribes, worked for nearly two decades reconnect the Klamath River. The dam removal campaign was a sprawling effort to restore what was historically the 3rd largest salmon run in the lower 48 states. Just a few weeks after the final coffer dam was breached, salmon made their way back into Oregon, heralding a new era for this incredible river. Chrysten Rivard, Oregon Director of Trout Unlimited, will present on the process to remove the dams, monitoring results to date, and what comes next to fully restore the Klamath Basin.

February 2025

Hard Work Pays Off

Well the jetboat issue has finally come to a close and we can claim victory. The Oregon State Marine Board (OSMB) made their final ruling last week. The ruling was to not allow charter boats of 7 passengers or more above the Table Rock Road bridge AKA TouVelle bridge. The decision is pretty much in line with the Rogue Fly Fishers original petition from 2017. I might be wrong on this time frame since I didn't join the club until 2018. At times I know it felt like I was speaking to a wall. I attended several meetings with the Upper Rogue Guardians, Oregon Kitchen Table meetings, spoke in person at one OSMB meeting and attended two others online. I'd like to thank all of you who wrote letters and attended meetings and gave me mental support in this fight. It looks like our hard work paid off.

Here is the resolution passed by the Oregon State Marine Board January 23, 2025

- (9) Upper Rogue River and its Tributaries:
- (a) No person shall use a motor in excess of 15 horsepower to propel a boat on the main stem of the Rogue River above Dodge Bridge County Park and Rogue River tributaries, between Fishers Ferry County Park and William L. Jess Dam, (Lost Creek Dam).
 - (b) In the event that the river flow rate drops below a three day average flow of 1350 cubic feet per second, ("CFS"), or equivalent water level of 3.20 feet, as measured by the United State Geological Survey USGS 14339000 Rogue River at Dodge Bridge, near Eagle Point, OR, use of a motor in excess of 15 horsepower shall be restricted between Fishers Ferry County Park and Dodge Bridge County Park. Restriction shall remain in place until the three-day average flow increases above 1350 CFS.
 - (c) In addition to the above restrictions,
 - (A) Charter boats may not operate upstream of Table Rock Road Bridge.
 - (B) Charter boats may only operate between Table Rock Road Bridge and Fishers Ferry County Park between May 8 and September 10.
 - (C) For purposes of this section, a charter boat is a motorized boat used to carry seven or more passengers for hire for angling, sightseeing or other recreational purposes.

We finally have some dry weather and more favorable river conditions. Hopefully some of you are out there enjoying it and catching some fish. Take care everyone and look forward to seeing you at the February dinner meeting.
