Outings

The final outing for the year was to the Klamath River in Northern California to fish for summer steelhead. Like the Rogue River, the summer steelhead in the Klamath make a halfpounder run, so they tend to be small; however, they will readily take a fly, and offer better catch rates then steelhead in many other rivers. The forecast for our late October trip called for wind and rain, however, the weather was much better than expected, with a little bit of rain and no wind. That, along with the beautiful fall foliage along the river, made for a pleasant day. There seemed to be a good number of steelhead in the river based on the number of fish we saw rolling and the number jumping at the entrance to the Iron Gate Fish Hatchery. Most of the people that planned to attend the outing dropped out for various reasons, so only three of us made the trip. Of the three, two hooked steelhead. The biggest thrill of the day was when Kevan Reiten landed his first-ever steelhead. Though Kevan is an avid fly fisher, he has mostly fished for trout and warmwater fish. He acquired a trout Spey just prior to the trip. After a quick lesson on how to make a couple basic Spey casts, Kevin was doing a pretty good job of casting and swinging his fly. His steelhead took a Skunk, and put up a good fight on the trout Spey.

We are beginning to put together the outing schedule for 2022. If anyone has suggestions of places you would like to go or if you are willing host an outing to one of your favorite fishing spots, please let me know.
